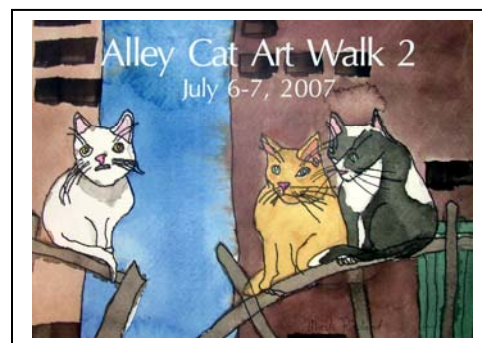

#### JUROR:

#### Artwork Criteria

1. Two-dimensional original fine artwork and photographs are accepted for exhibit.
2. All work must be for sale
3. FECA reserves the right to limit the quantity, type and subject matter of artwork, and to reject any artwork deemed inappropriate for the setting. Work must be suitable for family viewing.
4. Artwork must remain at the site for the duration of the show (unless sold). Once art is sold a replacement piece must be provided (subject to above guidelines).
5. Artwork valued higher than \$5000 will not be accepted for exhibition.

#### Fees:

1. You may submit up to five artworks. \$25 for one entry, \$10 for each additional entry (must be sent with application).
2. Each exhibiting artist agrees to donate to Sophie's Gallery (tax-deductible) 25% of pre-tax sales price of any artwork sold as a result of the exhibit.

**Artist vendor booths are also available to artist for the two-day event. Please call the El Cajon CDC at (619) 401-8858 to reserve space.**

#### Artists' Responsibilities

1. All related fees as described above.
2. Signed consignment agreement (sent with fees)
3. Bring artwork to Sophie's Gallery: 109 Rea Avenue, El Cajon, Ca. 619 593-2205,
4. Pick up artwork on scheduled collection date. \*\* Work not picked up by the deadline will be charged \$15 per day storage fee. Work will be disposed after 30 days.

#### Art Sales

Purchasers may pay by cash, check or credit card. ACAW will process credit cards and reimburse the artists by check. (Less 25% donation and taxes). Payment will be sent by mail within 30 days. The purchaser may take the artwork with them at the end of the reception. The artist is expected to replace sold paintings in a timely fashion.

### **Digital Submission Information**

Digital images must be submitted on CD in JPEG format with 1200 pixels in longest direction and rgb color. Multiple entries must be submitted on a single disc. Disc must be labeled with artist's full name and the title of EACH entry.

### **Hanging Criteria**

1. Frames, mats and Plexiglas (no glass) must be clean and in good condition.
2. Wire supports must be attached approximately 1/5 of the way down from the top of the frame. Paintings without wire hangers will not be hung.
3. Wire ends must be covered with tape to protect the walls and the volunteers.
4. Oil paintings must be dry.
5. All paintings must be framed, or on wrap-around canvases (all sides must be painted)

Paintings may be no larger than 38" on any side (including the frame) Saw tooth hangers are not acceptable. Artwork must be labeled, and correspond to the information on the entry form, CD and application.

June 28 Hand Delivery of Accepted Work 11:00 a.m. to 3 p.m.

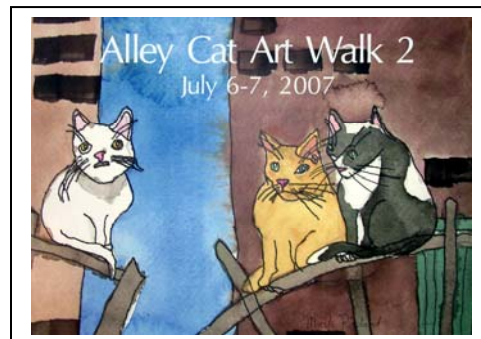
July 11: Show opens. Gallery viewing hours for the month of June will be: Monday – Saturday,
